## **TERMS & CONDITIONS**

1. I, the undersigned, agree and acknowledge that the Full Boar Archers Inc. (FBA) its Office Bearers, employees, agents and servants will not be held liable to the extent permitted by law for personal injury or property suits, demands, claims, actions, proceedings, losses, damages, liabilities, costs, or expenses arising out of any accident, injury, disease, or illness which may be caused or occur to myself or any other person in any FBA activity or function connected with the FBA or when travelling to and from such activity or function connected with the FBA or the premises of the FBA whether caused by the negligence or otherwise of the FBA, its Office Bearers, employees, servants or agents.
2. I agree to indemnify the FBA in respect of any legal liability, whether due to the negligence or otherwise of the FBA, its Office Bearers, employees, agents and servants and/or any other person or entity howsoever caused from my use of FBA facilities or participating in FBA activities or in any other way associated with the FBA
3. I agree I am responsible for any damage to my own property or equipment and I cannot hold FBA responsible for any loss or damage caused to my property or equipment, whether caused by FBA, its Office Bearers, employees, agents and servants and/or any other person or entity.
4. I agree to meet all costs associated with any loss or damage caused to property or equipment of the FBA as a consequence of such loss or damage being the result of my conduct, whether by my own negligence or otherwise.
5. I accept and acknowledge that the FBA activities may be dangerous and may involve an inherent risk of injury, or accidents causing death, bodily injury, disability and property damage. This includes injuries related to or resulting from pre-existing disabilities or medical conditions I may suffer.
6. I acknowledge and accept no assurance has been provided to me that I will be covered by any insurance for any injury, loss or damage I may sustain.
7. I acknowledge that safety precautions undertaken by the FBA (such as supervision, safety briefings, equipment instructions, usage instructions and equipment safety checks) are not a guarantee of safety.
8. I consent to receiving any medical treatment or injury assistance that the FBA feels desirable during or after my participation in FBA activities. I acknowledge that special medical facilities or equipment are not held or supplied by the FBA and I understand that treatment or assistance may not be immediately available when needed. I authorise such action being taken by the FBA and agree to meet all costs associated with such action, the said fees to be paid to the FBA on demand.
9. I understand that before participating in any physical activity, it is my obligation to obtain the approval of a qualified medical practitioner as to whether I am physically and medically fit to do such physical activity.
10. I must not participate in the FBA activities if I have an injury, disability, medical or health condition that may increase the risk of me becoming injured. I declare that I am medically and physically fit and able to participate in the FBA activities and I will immediately notify the FBA of any change to my fitness and ability to participate.
11. Use of bow and arrows either supplied by me or FBA are used at my own risk. The FBA is not responsible for injury, loss or damage resulting from the use of bow and arrows (including injury, loss or damage resulting or caused by the use of bow and arrows by other participants). In particular, FBA is not responsible for bow & arrow selection by or on behalf of participants.
12. By participating in FBA activities, I accept all risks necessarily flowing from my participation which could result in loss of life, temporary or permanent injury or economic loss.
13. I acknowledge I have read and understood the rules for shooting at the FBA
14. I will at all times comply with the rules for shooting at the FBA
